Professionalism, Resolve, Integrity, Determination, and Education.

P.R.I.D.E. I'm writing to you from Washington DC., where I somewhat nervously await our appointments

with Ohio's Congressman. It is our task to plead the case for Rural Carriers and the future of the Postal Service. Restructuring the prepayment of retiree's benefits and maintaining 6 day delivery is our main message. I mention nervously because there is a lot at stake. If Congress decides to allow the Postal Service to go to 5 day or even a flexible delivery schedule, it will mean sacrificing 50,000 relief carriers from the rural ranks and will probably result in a Postal Service that carriers from recent history would not recognize.

As I look across the Potomac towards Arlington National Cemetery, I am quickly reminded of the huge sacrifice made by those souls represented by the rows and rows of white markers. With Memorial Day approaching, I can't help but wonder what makes people finally decide to take a stand? To make a sacrifice in the name of freedom and what is right and fair. When do we decide to become involved, stand shoulder to shoulder and push back against policies and actions that we know are detrimental to the way we earn a living...our way of life? Why does it take some major catastrophe for us to realize that we should have taken action beforehand?

As I travel to many meetings across the state and nationally, I see pretty much all the same faces. The same few members that have decided to get involved and serve our union and try to protect it's future. Getting involved doesn't have to be a major undertaking. It can be just buying a raffle ticket to support PAC or attending convention to hear about the latest issues that will be affecting the way we earn a living. How much sacrifice would it take for you to call or write your representatives to educate them on what we do and how we are different from the other crafts. It can also mean just talking seriously with a non-member fellow carrier and encouraging them to become a member. Hardly the sacrifice paid by those men and women memorialized in Arlington. 


Steve Traylor was elected to a

May Mail Count

All FSS site offices in the Cincinnati District (old Columbus District) went through a May Special Mail Count from May 9 through May

21, 2011. The standard to be used for this count came back from the arbitrator in the middle of count. The standard that was decided by the arbitrator was 43 pieces per minute. The Union was arguing 17 pieces per minute and the USPS was arguing 69 pieces per minute. If you add 26 to the 17 and take 26 from the 69, you will get 43 pieces per minute. It looks like the arbitrator just divided the argument with the 43 pieces per minute.

A National Step 4 grievance was filed by Don Cantriel, NRLCA President, on May 19, 2011 against the USPS for violating the December 21, 2007 Memorandum of Understanding between the USPS and the NRLCA. The parties agreed, in the MOU, that a standard of no more than 27 DPS flats per minute shall remain in effect until "a different credit is later established through settlement or Article 34," and that if a new credit is established, "it shall be used beginning with the next mail count." Also, the MOU states that "NO retroactive adjustments will be made." (Please read the whole Step 4 on OHRLCA.org or NRLCA.org.) The USPS clearly has violated this MOU.

DPS Flat Impacted Offices and 50-Mile Radius Offices

Calls have been coming in to my office about holding of routes due to DPS flats. The USPS and the NRLCA released 45 routes in the old Columbus District and 9 routes in the combination of the Northern Ohio District and the Cincinnati District. These routes were released due to the amount of routes being held. The MOU on holding routes has never been lifted. Routes are being held in the impacted DPS flat offices and any offices within 50 miles of an impacted DPS flat office. Now that there is a DPS flat standard of 43 pieces per minute, routes may begin to be released as early as August, 2011 and as late as February, 2012. This will all depend on the outcome of what is argued on the May 2011 Special Mail Count. I will keep you informed on this issue on the Ohio Union website OHRLCA.org.

Delivery Unit Optimization (DUOs)

"USPS Tracking #"

The "USPS Tracking #" barcode with a pink line across the top is now on packages, oversized letters, and flats that have NO extra services. This service is on items that have postage weighed and affixed over-the-counter by a clerk. The items will also receive a "delivered" scan. Extra credit for these scans will be credited to the route at the next mail count unless a grievance is filed by the National office on these increased scans.

In accordance with the Constitution of the National Rural Letter Carriers' Association Article IX, Section 6, this notice hereby constitutes written notification to all NRLCA members that an election shall be held for the position of a Local Steward in their office. Failure of members to exercise this right will result in the local office being assigned representation in accordance with the Constitution of the National Rural Letter Carriers' Association.

The selection of a Local Steward should be in accordance with democratic procedures. To become a steward, a rural carrier must be a member of the National Rural Letter Carriers' Association. Local Steward Elections will be conducted in the month of July of every fourth year (i.e.; 2008, 2012, 2016 etc.) unless the incumbent Local Steward is unopposed. The Steward shall serve until a successor is elected and certified or until he or she resigns. An election may be called any time the position is vacant, or when a majority of the members submit a petition to the State Steward for approval a Local Steward may be re-elected to the position. Written notification to all NRLCA members shall be given at least 15 days before the date of the election. A majority vote of those NRLCA members voting is required for an election. When there is more than one (1) Local Steward at an installation, including stations and/or branches, a Chief Steward will be elected by the NRLCA members of said office. Re: Article IX Sections 6.B.1, 2, & 3 of the NRLCA Constitution

Nominations will be accepted at the time of election and any dues paying members of the National Rural Letter Carriers' Association can announce his/her intention to be a candidate by signing below:

They print and mail the paper utilizing the mailing list provided by the secretary. You do not need to do anything regarding updating mailing lists etc.

The equipment that comes with the job are: a Dell laptop, wireless key board & mouse, a Dell 4 in one printer and a large screen monitor as well as a digital camera.

You can reference the constitution for what compensation, both in salary and ADOP and office allowance you will receive.

After the convention the newly elected board will select an editor, using among other considerations this application process, After the new editor has been named, if needed, I will be glad to work with them until they can take over.

We are seeing what may happen to our Public Workers. Could we be next? There are allot of new faces in DC and most of them are of the same mindset as those

who have crafted bills that will eliminate Collective Bargaining in the States. Can you image what would happen to our jobs if we lost the ability to negotiate? Collective Bargaining is very valuable to all workers. We have a say in salaries, benefits, and safer work conditions. Without Collective Bargaining and arbitration decisions, we would be forced to live with whatever the Postal Service comes up with.

I took some vacation days to go to Columbus to stand with fellow union workers to help preserve their collective bargaining rights. I spoke with many people to see how this would affect them. I also spoke with postal workers from other crafts. If you were among the many people who took the time to protest at the State Capital, I would like to thank you for being there. We now have an opportunity is sign a petition to repeal SB 5.

UNIONS MADE THE MIDDLE CLASS. America had the most growth in the 50's and 60's when the membership in the unions was the highest. A strong middle class makes a strong nation. It makes the economics of a country work.

A few days later, I heard on the radio, that in 1934 the Postal Workers were the first to use collective bargaining. I then referred to Lester Miller's book "National Rural Letter Carriers Association: A Centennial Portrait" In 1934 the NRLCA had joined in the formation of the National Legislative Council of Federal Employee Organization, which represented 150,000 postal and federal workers. They were able to achieve a five cent increase in EMA.

Committeeman Aitchison recently quoted the phrase, "you don't know what you've got till it's gone. We need to be very watchful not to lose what the rural carriers before us obtained to make our jobs safer and build on our evaluations. Our retired rural carriers did not start out with the benefits we have now. We owe a great deal of thanks to them for their persistence and their fight to get these benefits. I hope you took the time to call your Representative and Senators on March 8 to not make cuts to the retirement and health benefits for our retirees

We need to stand united to maintain the standards and benefits we have worked hard to achieve over the years. Our contract expired on Nov. 20, 2010. We are awaiting a new contract. We all need to get involved and educate ourselves so we are getting the route evaluations that we are entitled to and to make sure that we are up to date on any changes.

I would like to encourage you to write Congress to maintain 6 day delivery. If we keep cutting service to our customers, what do we have left? United States Postal...where is the SERVICE!

I also encourage you to remember to give to PAC. This keeps the members of Congress informed about our jobs. A new bill to preserve 6 day delivery is Res. 137.

COMMITTEEMAN FLOYD EDLER APATHY



Why is apathy,

reaching epidemic proportions

when it comes to social, economic, environmental, and political issues? Symptoms include lack of awareness, concern, social responsibility and action, including voting.

Among the factors that cause apathy is our society's orientation toward entertainment. We have become a nation of observers watching with increasing enthusiasm as the sensation of the show intensifies. Presidential debates have even become an integral part of the entertainment industry. If there are no fireworks, no Jerry Springer type show, then their ratings fall way down.

How can we take politics seriously, when opposing candidates, like actors, are trained to perform in a certain way in order to appeal to the voters? Each has been prepared by their campaign experts with a bulwark of information. The debaters are trained to use that information to portray themselves in the most compelling manner possible in front of the television cameras. The audience seems to base its judgment on the cliché's, slogans, and bloopers. Like an aspiring Hollywood actor or actress, charisma appears to be the final determinant as to who is the victor.

Since television networks depend upon advertisers for profit, the debates must cover a wide range of topics in a relatively short period of time. The television networks realize that the general public is not interested, nor does it have the patience, to listen to thorough, in depth discussion. In addition, we are bombarded by short, rapid fire, political ads. These are cleverly created to appeal instantaneously to our emotions, not necessarily to our reasoning. Therefore, it can be concluded that television medium impacts our apathy.

Politics aside, the consumer in our society is another factor that fosters apathy. We have become addicted to buying numerous products that we imagine make our lives easier and more appealing. For instance it is easier to get a "Big Mac, fries, and a shake at the drive through window, than it is to microwave a TV dinner at home. What ever became of taking the healthier and less expensive option of preparing a meal at home from scratch and eating it together with the family? Since we have material desires, why should we be bothered if our inability to pay off our credit cards at 18% interest causes marital problems? Why should we be upset that we have little time to spend with our children because both parents are working so bills can be paid? Do the kids really need us? After all, they have boom boxes, TVs, video games, computers, and, as teenagers, many have cars—all for entertainment.

In other words, we allow ourselves to be dominated by consumerism, the entertainment industry, and the television media. Almost instinctively, we desire instantaneous gratification. We are also controlled by our upper management, supervisors, and associations. In fact submission is actually the opposite side of the coin of control. It is easier to be passively controlled, than it is to take initiative.

It is also easier to control others than it is to stand up for principles. By controlling others, the enforcer tries to make sure that those under his or her control do not make waves. By attempting to impose compliance to the status quo a sense of stability and security appears to exist. Whether it is the employer or supervisor in the business world or the administrators of others. The role of the administrator is to make sure that his or her employees or members learn not to question but to submit to the guidelines of their superior.

Although business uses the language of critical thinking, problem solving, effective communication, team building, respect, trust, oversight and social responsibility and involvement, the bottom line remains accountability. It is a difficult and challenging process to encourage and to motivate individuals to take on responsibility, to become socially, culturally, economically, and environmentally conscious. In closing, get involved your rights and benefits depend on it.

SECRETARY/TREASURER PENNY KOREN OHIO UPDATE

Membership

I attended a Secretary-Treasurer meeting at the Mid-State Conference, May 6, 2011 in Des Moines IA, the topic of the discussion

was how the membership totals have dropped in the last year. The decline is contributed to recent retirees not renewing their membership and the hiring of TRCs. Ohio has not hired a RCA in over 18 months.

As of May 18, 2011 the National Membership Analysis has Ohio's total membership at 4,427. The same report dated March 19, 2011 showed a total membership of 4,504, a loss of 47 members in a 2 months period.

A reminder, Ohio's voting strength at the National Convention is based on the membership for the new Association year 2011, divided by 100, minus the associate members (30) which would allow Ohio to have 44 delegates for the 2011 National Convention. Last year Ohio had 4,612 members, for 46 delegates at the time of the Credentials Committee Report at the National Convention. The state needs 155 more members to be entitled to the same amount of votes during the 2010 National convention.

Cash Dues

The cash dues collection for the 2011 membership year, beginning July 1st, has begun. For those of you that use the cash method of dues payment, National has taken a strong position on the constitutional provision that dues are to be paid before the start of the membership year. Thus, there will no longer be a grace period after July 1st for those who have not paid their cash dues. If your dues have not been paid by July 1, 2011 you will not be a member in good standing and thus will not be permitted to be a delegate to the State or National Convention and will not receive a ballot to vote on delegates for the National Convention. To avoid being removed as a member in good standing dues withholding is available to all classes of membership. A notice along with a dues withholding form was sent to all previous cash paying members. If you did not receive it and want one, please contact me.

Members on OWCP

Members receiving their compensation from Worker's Compensation, your dues withholdings are not being withheld from your pay. After 3 pay periods you are no longer considered a member in good standing. If you are not a member in good standing you are not entitled to vote in any elections. If you were not a member in good standing at the time of nomination you cannot be a delegate to the

State or National Conventions. You may be entitled to reinstate your membership using the cash dues method, contact me for additional information.

National Delegate Ballot

The procedure for handling the election of Delegates to the National Convention is that once the election committee, at the convention, retrieves the ballots, the membership of each member voting will be verified. It is at this point only members in good standing for 2011 will have their vote counted. If you want your ballot to be tabulated, you will need to have your dues paid before June 30, 2011.

District Secretaries

Once again this year President Gamble has scheduled time on, July 9, 2011, Saturday evening 8:00 p.m. at the State Convention for review of your financial records and hopefully we can complete your LM forms. This will be for all district secretaries. More information will be forthcoming but please put this meeting on your schedule.

- A. Neglect of duty or breach of the Constitution.
- B. Conduct detrimental to the welfare and interest of the membership of the Association
- C. Conduct which hinders the due process of the grievance procedure.
- D. Instigating or engaging in the acts on the side of management that violate the principles of the National Agreement or Constitution

New Board Policy

Telecommunication lines and devices supplied or required by the association shall be considered an authorized expense and covered by the association, which will include line item calls by Assistant, Area, and Local Stewards.

New Board Policy

All transfer and or disposal of equipment must be authorized by the Executive Board.

CONVENTION RULES

OHIO RURAL LETTER CARRIERS' ANNUAL CONVENTION

- 1. A Delegate speaking from the floor shall rise, address the Chair and obtain recognition from the Presiding Officer. The Delegate shall then give their name and the District they represent.
- 2. No Delegate shall speak twice on the same question, except by majority consent. No Delegate shall be recognized to speak a second time on the same question if a Delegate who has not spoken asks for the floor. Non delegates may be recognized to speak if no Delegate asks for the floor
- 3. Debate shall be limited to two (2) minutes to each speaker. Debate on any question shall be limited to twenty -five (25) minutes. No extension of time shall be allowed a speaker to debate a question, except by unanimous consent.
- 4. A report by a Chairman of a Committee shall be deemed to have been moved for adoption by such Chairman. No second to the motion to adopt will be required, as the approval of the report by other Committee members shall constitute an appropriate second. Following debate on the motion to adopt, the Presiding Officer shall call for a vote of Ayes and Nays.
- 5. Each proposal to amend the CONSTITUTION AND BY-LAWS shall be considered separately. After debate on the issue, the Presiding Officer shall call for a vote of Ayes and Nays to adopt the proposal.
- 6. The Convention will only address Constitution Amendments and Resolutions that have been reported out by the Constitution or Resolutions Committees. The Convention may suspend the rule by a majority vote and consider any Constitution Amendment or Resolution under New Business.
- 7. In considering the RESOLUTIONS COMMITTEE REPORT, the Courtesy Resolutions may be approved as a Unit. Other Resolutions shall be considered separately. In accord with Rule *4 above, upon the reading of the Resolution by the Chairman of the Committee, it shall be deemed to have been moved for adoption and is properly before the delegates for appropriate action. If there are no objections to a Resolution within a reasonable time, it shall be considered adopted at the fall of the gavel. If there is an objection to a Resolution, it shall be passed over and acted upon after completion of the reading of the full Committee Report. Following debate on each Resolution, including amendments, the Presiding Officer shall call for a vote of Ayes and Nays on the motion to adopt. This procedure precludes any motion to strike or reject a Resolution and any such motion would be considered out of order.

- 8. All Resolutions shall be referred to a Committee on Resolutions before being discussed by the Convention. These Resolutions shall be in the hands of the Committee not later than the close of the first day's session. Resolutions must be signed by the person or persons presenting them. Likewise all Constitution changes must be in the hands of the Law Committee by the close of first day's sessions. Any one submitting changes after the deadline must supply copies at their expense.
- 9. In accord with Article VI, Section 3, Paragraph F which states in part "that where a District is represented by less than a full delegation, the delegates present may vote the entire district vote", such voting shall be done by one of the following methods:
 - The district delegates may caucus and agree by democratic procedures to cast all the District votes for the same candidate or issue; (In this instance, any delegate may claim their own vote), or,
 - b. The delegates may choose to divide the District votes by the number of delegates and distribute that number to each delegate. Any fractional vote shall be forfeited unless:
 - 1) The delegates agree to allow the person in charge of the delegation to vote the remaining votes at his/her discretion; or
 - 2) The delegates choose to apply the Unit Rule to such votes.
- 10. As per Article XII, Parliamentary authority for the Conduct of Business shall be "Roberts Rules of Order".
- 11. There will be no smoking on the Convention floor.
- 12. No campaign signs are to be posted inside the convention meeting hall.
- 13. While on the convention meeting hall floor, all cell phone and/or pagers are to be operated in such a manner as to not be audible while the meeting is in progress.
