

evening, July 7, 2014 at his home. He was born April 17, 1926 in Prospect to the late Samuel and Hazel (Thomas) Lauer.





The PAC Report

The Ohio Rural Letter Carriers efforts over the past year have had positive results in affecting our destiny and the fate of the United States Postal Service. Most recently, the appropriations bill that was voted out of committee again contained language that requires service levels at no less than 1983 levels, which in effect maintains 6 day delivery. This provision was omitted from the original proposed bill, but

an amendment was offered up from the floor to reinsert it. An Ohio representative, Marcy Kaptur of the 9th District, rose to speak in favor of the amendment. It was passed by a voice vote.

Another example of progress on the congressional front is illustrated by the actions of Ohio's Senator Rob Portman. Senator Portman sits on the Homeland Security and Government Affairs Committee. He voted No on a proposed bill with provisions that were harmful to the Postal Service and its employees, when just a year ago, he would have most likely supported the bill.

Much of Rep. Issa's influence and control over postal issues result from his being the Chairman of the Oversight and Government Reform Committee. There is a term limit for that position and Issa will be rotating off this November. One of the leading contenders as his replacement is Ohio Representative Michael R. Turner of the 10th District. If Turner should get this position, it would give us a great opportunity to have a greater impact on influencing these postal related bills. Turner voted in favor of Issa's bill that would have had 15 million american families with door delivery moved to CBU delivery, a vote that disappointingly went right down party lines. Rep. Turner is currently serving on the Armed Services committee, and he took a leading role in investigating the gutting of the retirement benefits at General Motors. Hopefully these experiences will make him more aware and sensitive to postal issues as a high percentage of veterans are employed by the USPS.

I hope that everyone that attended the reverse raffle and basket auction following the banquet at the State Convention had a great time! Again, I am so proud of the Ohio rural carriers that participate and how they step up to the plate to fill a need or answer a call. The events were a success for our fund raising efforts. Our , who won the early first winner of the evening was bird drawing for a dash camera. The other prize winners were Shirley Ortz winning a dash camera; Tom Noble, winning and donating back to be auctioned, a GPS; Lori Todd, a double winner receiving a Kuerig coffee machine and a commercial quality gas grill; Elaine Ferguson winning an I-Pad; Barb Pitts winning a pressure washer; Dawn Greene won a large screen smart HD TV which was donated back to be auctioned; and Lyman Chidsey, another double winner who won not only a Mini I-Pad, but also the grand prize thousand dollar gift card.

Lyman Chidsey is a retired carrier out of Medina, OH. He has been retired for the past eight years. He retired at the age of 68 following lung surgery. Chidsey had the good fortune of being able to go regular in '87 after only fourteen months as a relief carrier. He is proud of scoring 99% on the civil service test, and then received five bonus veteran points.

DR Northern Ohio District Year End Report

Distinguished guests, fellow officers, delegates, and all members of the OHRLCA assembled here in Newark for our 112th Annual State Convention. It is indeed an honor and a privilege for District Representative me to present my Annual Report as your First District Representative under the National Steward System.

Following the 2013 State Convention I served as a national paid delegate at the National Convention in St Louis, MO. I was proud to be a part of this democratic process as I helped elect six officers to the national board. David Heather was elected as Director of Steward Operations and has been doing a great job as the leader of the National Steward System. The Convention brought much spirited debate and was historical on two accounts.

Following the Board of Governors decision not to support Post Master General Donahoe's position on 5-day delivery, PMG Donahoe sent a letter to all the unions asking to reopen our contracts for negotiation. President Dwyer responded with an emphatic "NO". This attempt by the PMG to circumvent our CBA was not well received by the body of the convention.

The second and most historical part of the convention was the announcement of the Engineering Time Study that will forever change the evaluated system and how rural carriers are paid. As many of you are aware, one of the most important parts of the Interest Arbitration Award of July 3, 2012 was the creation of a three member panel of industrial engineers. They will establish the means to collect data and that data will establish appropriate time standards to be used in the evaluated system to calculate route evaluations. Ohio has many offices that will be included in the Study and as you read this report the Study should be in full swing. The new scanners will be included in the Study and you can read more on the new scanners in the National Magazine May edition. I will be working closely with District Representative Cathy Funderburgh (Ohio Valley Dist.) to insure that the Study is conducted according to the MOU. We will have two union officials on site during all studies conducted in our districts that make up the state of Ohio.

Following the National Convention I returned to Ohio with a very busy fall schedule. I attended seven district meetings, three as District Representative and the rest as a guest of the association. I spent long hours educating myself on Postal issues that matter to rural carriers and appreciate the opportunity to share this information at your district meetings. My assistants ADR Susan Thayer and ADR Chris McCoy helped to answer questions and educate carriers on contractual issues. Your feedback is valuable to us and I have discussed all of your concerns with President Gamble and our National Committeeman Steve Traylor. The steward system in Ohio is not a one man operation. I could not do this job without the support of my fellow stewards and the State Board. It is truly a team effort in managing this association and we work hard to resolve all of your issues.

I conducted six local steward certification training classes this year. If you would like to be a local steward please contact me and I will send you an election form and get you scheduled for training. The National Steward System has changed the deadline for steward enhancement training. The national Constitution mandates that all stewards complete enhancement training and there will be five classes scheduled following this convention in July. Currently there are 45 local stewards scheduled for training. The classes are on weekdays with the local steward receiving \$256.80 plus mileage reimbursement to the training site. As you may be aware the Area Stewards are chosen from this fine group of individuals. We presently have two Area Stewards in the Northern Ohio District. Mrs. Tana Humphrey and Mr. Jason Zedaker continue to serve carriers in their assigned offices with skill and professionalism.

The National Mail Count in February / March seen the majority of carriers opting out of the Count. The Northern Ohio District mandated that approximately 38% of all routes be counted. This was slightly lower than the national average of 47%. I scheduled five mail count training classes across the district and trained 300 plus carriers. The mail count data showed that the free fall in mail volume was over. Mail volume was flat in some areas and off the charts in others, but overall we seen a slight increase that resulted in higher evaluations. Most routes seen priority parcels up 38% and scans up as much as 24%. I received a large volume of phone calls from carriers at this time. Most calls were a result of inexperienced managers causing confusion in the field. I set up a daily phone schedule meeting with the district rural analyst to discuss issues as they arose during the mail count as a preemptive measure to resolve issues before they became grievances. I believe this preplanning and an increase in mail volume resulted in a much lower than normal grievance activity. My team of stewards and I as well as President Gamble physically inspected all the plants and distribution centers at the beginning and end of the mail count. The team found no major discrepancies to report. We were able to keep the pressure on management to get the mail out of the plants and into the AO's during the mail count period.

I attended the Mid-States Conference in Duluth, MN this past May. Ohio was well represented at the conference with carriers and Board members. The major topic was Sunday parcel delivery. I found the conference to be very informative and I was not disappointed in the level of discussions and topics affecting the rural craft as we go forward into 2014.

For this portion of my report I will deal with grievance activity in the Northern Ohio District. Grievance activity has remained strong over the past year. We have processed approximately 226 grievances with 55 being discipline issues and 165 being contractual with 6 being class actions. The discipline grievances range from express mail late delivery, scan failures, misdeliveries, failure to follow instructions, motor vehicle accident, abuse of leave, and theft. Removals in the district have not changed over this period last year but there has been a slight spike in seven day and fourteen day paper suspensions. There was a substantial drop in mail count grievances as most issues were resolved at the district level.

I have been busy attending pre-disciplinary interviews with management. This is important because we can sometimes prevent further action by management at these meetings. The stewards have worked very hard to settle most issues at the lowest step of the grievance process. In most cases a grievance will be settled with the grievant being notified as to the resolution within 30 days of filing. We never have more than 5 grievances at the step 2 level on any given day. Ohio is the sixth largest state in number of rural routes and in the Northern Ohio District I have only appealed one grievance to step three compared to almost 800 for the rest of the country. We have been very successful in getting favorable settle-

of the rural craft. Next, I want to thank my full time assistant, Michael Aitchison for your dedication, hard work, and all of those late nights, early mornings and weekends. I could not do this job without him. My part time assistants Randy Anderson and Randy Burger – I am so fortunate to have you in my District. Your wealth of knowledge and experience is so precious. Each of these stewards has form relationships at the district level which are a benefit to you and has allowed us to solve problems before they become a grievance. Thank you to my area steward, Philip Burnside, as well as Michael Sikyta who will be missed. Thank you for his years of service and dedication to the rural craft. To all of my 45 local stewards - thank you for being on the front lines. Being a local steward is sometimes a thankless job but in the past year I have come to realized that I have very capable local stewards who are willing to stand up to management for the betterment of the rural craft.

ENGINEERED TIME STUDY: History is being made and your stewards will continue to be present for all of the time studies to make sure that management does not try to influence the engineer in any way. We went into the office ahead of time and gave a service talk about the time study, spoke with the carriers that would be actually participating in the study and what was to be their role. On the test day, your stewards were in the office to ensure that there was no interference by management as the engineers are in complete control of the study. This is very time consuming but we will ensure that the NRLCA receives the best standards for what we do on a daily bases.

SUNDAY DELIVERIES: Sunday deliveries are going strong in the District and it is vital that we continue to grow our business to ensure that the Postal Service remains financially strong in the years to come. More and more hubs have been added and my ADRs and I have worked on Sundays gathering information for the National Office. Some of the problems we have seen are late arriving trucks, manifest that didn't down load, parcels that wouldn't scan, RCAs being forced into work and the Sunday Work List not be utilized, RCAs being required to stay home to avoid over time, and accidents.

MAIL COUNT: Mike Aitchison conducted two classes and I conducted five classes for mail count training. These classes were held in free locations such as libraries as we work hard to keep expenses down and spend your union dues wisely. The district counted 1161 (70%) routes and although we may have seen some drops in certain columns; parcels were up 32% in the district which means non signature scans, and loading time all went up as well. Most routes either stayed the same or saw an increase in their evaluation which in turns means a bigger paycheck for you. We were in the plants inspecting every corner of the buildings to ensure that the mail was flowing out to your office in a timely man-

ner and visited the Sunday hub offices to ensure that only Amazon parcels were being delivered.

GRIEVANCES: The stewards in the district have handled 235 contractual cases, 77 discipline cases and 38 class actions for a total of 350 grievances. However, this does not include the number of grievances that were avoided by placing a phone call. Once again, I have found that a lot of the discipline/contractual issues are related directly or indirectly to the lack of relief carriers. We can not continue to solve management's problems due to the lack of RCAs. Other contractual issues are mail count, carriers working off the clock, regular carriers carrying other routes, full day of relief, violations of the RDWL, compensation issues, denied leave, route adjustments, OWCP issues, Letter of Demands, route postings/consolidations, seniority list, matrix violation, RCAs not being hired, and hostile workplace. Of the 77 discipline cases, there were 19 removals, nine 14 day suspensions, twelve 7 day suspensions, 20 Letter of Warnings, and 18 Emergency Placements. Grievances are being settled 96% of the time at either Step 1 or 2. Discipline issues include missing scans, express mail failures, maintaining a regular schedule, dog bites, delaying mail, failure to follow direct orders, theft, not reporting an accident and motor vehicle accidents.

TRAINING: Training is vital for the future of the Union and the steward system. All my ADRs and I have taken the time to work and develop our local stewards as they are the future of the steward system. When local stewards are over whelmed, I sent Mike or myself in to help with the step 1 meeting or to help handle the OIG interviews. I have sent local stewards a critic of what they did great in their file and what improvements could be made. I wrote articles for three state papers trying to educate the rural craft on various issues. We tell every carrier to document their mail count issues and I made a mail count dispute tracking sheet that is now on share point for all stewards across the country to utilize.

LLVs/Motor Vehicle Accidents: The rural craft will be receiving an additional 215 LLVs to be assigned to rural routes meaning that 65% of the rural craft will have an LLV. After numerous conversations with management, one of the major contributing factors in not hiring an RCA is that they do not have a car. If there is a vehicle assigned to the route then there should be no more excuses for not hiring a RCA. Accidents are down among regular carriers but there is a huge increase with RCAs having accidents. I have attended USPS District Labor/Management as well as the District Safety meetings. These meetings are vital as we can bring forth the concerns of the rural craft to the District Manager. I have met with the district manager, MPOOs, operation support staff and many postmasters and supervisors to discuss the issues and concerns of the rural craft. I have conducted new local steward certification classes and am currently planning the mandatory local steward enhancement training classes. I have attended two state conventions and participated in booster meetings, district and local meetings and membership building meetings in three states. I attended two National Steward Training Seminars and the Mid-States Conference in Duluth, MN, where valuable information was presented at all of those meetings. I served as a delegate to the National Convention in St. Louis and voted on numerous issues affecting our jobs.

In conclusion, we have many challenges facing the NRLCA

Membership

The 2013-2014-membership year began with 4,147 members and as of June 15, 2014 our total membership was 4,250, an increase of 103 members. Ohio was on a steady downward trend in membership, which ended in August 2013. After this convention, I was given the legislative support position, to keep everyone informed as to what the U.S.P.S. is trying to accomplish by persuading congress to believe that gloom and doom is about to fall out of the sky, and the post office needs to privatize to be competitive with everyone else. The only reason they want them to believe that is so they can do away with six-day delivery and close the smaller post offices that do not make big bucks for the U.S.P.S. We are here to provide a service and we, the rural carriers, do that

with a smile every day that we deliver.

I have some large shoes to fill, but I will do my very best to keep Ohio in the heart of the Legislative battle ground. While looking at some news I found an interesting article from South Dakota. The South Dakota Newspaper Association issued a statement against the U.S.P.S. for consolidation of more closures, citing further delays in delivery times, after the postal service announced the closures in the second round of "Network Consolidations" it goes on to further state "Though the U.S.P.S. is showing operating profits this year after several years of red ink." The SDNA represents 127 weekly and daily newspapers with a total readership of more than 600,000 people. If the post office is operating in the black wonder how long before management gets a bonus, or cola's, I believe is what they are called now. Senator Murkowski reached out to the CEO of fed ex to find out why people in Alaska are not receiving their packages to their door. Fed ex wants the post office to go the last mile and deliver these packages to the door when the address is listed as a P.O. Box address. No other address is listed. Fed ex came back with we are convening a special task force to look into the problem. REALLY? Why not just say we don't want to deliver the darn packages. After receiving a response from fed ex they explained that they would be placing the addresses on the P.O. Box packages that they receive for Alaska post offices.

How many people would be out of work if the U.S.P.S. went to five day delivery?

It all depends on whom you ask; if you talk to Congressman Gerry Connolly it would be only 25,000 people. The number of rural carriers is about 53,250. The NALC say they will lose about 26,000. Rural carriers have declined about 7 0/0 since 2009 as have city carriers. Here is what the U.S.P.S. thinks of the RCA position as a whole, "If you are retired, self-employed, an at home parent, an educator, night student, or are employed on an evening shift schedule, this on-call position could be the ideal job for you" I think this pretty much envelopes everyone who has applied for this position in the past , oh I don't know fifty or so years. DUH!!!!!! What are they thinking.

Now for the main topic I have wanted to get to for a couple of months. After going to district meetings, new hire orientations, the spring booster, and lastly state convention, the one comment that is always brought up is "what has the union done for me?" the Union has done numerous things for everyone, some are we are the only craft that still has the no layoff clause in our contract, U.S.P.S. has wanted us to give that up for the last two negotiations. Overtime pay for working your relief day, COLA's, PTF positions for RCA's, management does not want these positions filled because they have to pay them retirement and benefits, we still have the option to case DPS letters if we are not over our 2080 hours,

Free Saturday leave for carriers who take all week off, Protection of carriers during the elimination of sub-standard routes, choices of different health care benefit plans, education of carriers through social media, magazine articles, district and state meetings as well as state conventions. Giving **you** the necessary information to complete a mail count and obtain every cent that is possible to get for your route that you do on a daily basis, negotiate your contract with the U.S.P.S., favorably for the most part, sometimes forced on us by an arbitrator, letting you voice your opinion through the democratic process, giving you an opportunity to become a leader in this organization, whether it be on a county, district, state or national level.

Now that I have told you some of the things your union has done for you, I would like to ask "what have **you** done for your union?"

Have **you** filed a grievance?

Have you attended any district meeting?

Have you attended any mail count trainings?

Have **you** let someone other than your co-worker know of any potential problems in your office?

Have **you** educated yourself to what the contract stated?

Have you talked to your steward in charge of your office?

Is there a local steward in your office?

Have **you** voted for a steward in your office?

Have **you** initiated change through a resolution or constitutional submission?

Have you read your state magazine articles?

Have **you** read your national magazine articles?

The third group I see is our juniors, all the young children that don't even work for the USPS yet. We will raise and train these young people to someday take our place in the USPS and our union so that we will be able to have a comfortable retirement.

I plan to educate myself and study every issue that is brought before me and make common sense decisions that will be best for the entire body, not just small special interest groups. My goal is to build a stronger union by increasing our membership and uniting our union in the state of Ohio. I am eager to learn and serve on our state board.

2014 Ohio Constitutional Change

#1

Article III Section 5 Paragraph J

Past Language:

J. Retired Associate Members. The per capita tax shall be \$25.00 annually for the State Association, plus National per capita tax.

New Adopted Language:

J. Retired Associate Members. The per capita tax shall be **\$216.00** annually for the State Association, plus National per capita tax.

#2

Article V Officers and Appointees Section 5. Expenses A. Past Language:

All elected State Officers, with the exception of the full time secretary-treasurer, who are required to be absent from their duty station with the U.S. Postal Service to fulfill the duties of their office, shall be paid an Association Day of Pay (ADOP). All elected State Officers who use any unscheduled day of work to fulfill the duties of their office, shall be paid an Association Day of Pay (ADOP). (An ADOP is generally considered to be equivalent to their daily or hourly rate of pay less statutory required deductions). This is to be on an as needed basis, subject to the approval of the Executive Board. No ADOP will be paid for attendance at statewide meetings. In the event the State Officer is retired, he shall receive pay for 8 hours at the current rate for Schedule I RCA carriers. The Editor shall receive the same consideration subject to the approval of the President with review by the Executive Board.

New Adopted Language

Article V Officers and Appointees Section 5. Expenses A.

All elected State Officers who are required to fulfill the duties of their office, shall be paid an Association Day of Pay (ADOP). (An ADOP is equivalent to the rate of pay for a 46 hour rate of pay at step 12 less statutory required deductions). This is to be on an as needed basis, subject to the approval of the Executive Board. The Editor shall receive his/her daily or hourly rate of pay less statutory required deduction, subject to the approval of the President with review by the Executive Board.
