The Health of your Union

Your personal health and the health of your union go hand in hand and have many similarities when you stop to think about it. While caring for yourself, you should not wait until you have a major problem, such as a stroke or heart attack, before you do something to address the situation. The best way to prevent a major event is to keep up with your health, such as proper diet, exercise, adequate sleep, etc. The same can be said when talking about your union. You should not wait until you have a major problem before getting involved with the union. Put in the time to keep your union healthy, such as going to district meetings, state conventions, and national conventions, donating to PAC, checking the national website, and reading the newspaper articles to educate yourself and help prevent a major problem. If you keep up with the small stuff, you can help prevent or reduce the risk of big problems occurring later. Just as you need to invest time for yourself to stay healthy, we need to invest time in the union to keep it "healthy" and running smoothly.

There are a few updates that I wanted to bring to your attention. You will see a general wage increase that goes into effect on 11/18/23 (pay period 25), and the increases will appear on your 12/8/23 paycheck. Also, open season for health insurance is from 11/18/23 to 12/11/23, so I hope everyone had a chance to review their health insurance benefits and make any necessary changes. In 2025, the post office will begin their own branch of health care insurance, but we are still waiting to hear the details on this. By the time you guys are reading this article, the new MDD scanner functions will hopefully be in place. This was done to assist us as rural carriers and reduce the number of common scanning errors such as clock in/out, start load vehicle/end load vehicle, out and return to lunch, etc.

On October 19th, H.R. 5995: The Federal Retirement Fairness Act (FRFA), more commonly known to rural carriers as the "buy back bill," was introduced. This would allow carriers with any temporary position after 12/31/88 the opportunity to buy back credit for their service. At our last RRECS training, we collected signatures to support HR 5995 and are making an end of the year push to inform Congress and ask them to co-sponsor. This will affect not only USPS employees but all federal employees who started as non-career workers. You will find a form letter on the national website that you can just sign your name and mail in or use as a reference to create your own letter and mail it to your representative.

I look forward to seeing you all at the spring district meetings. Please take care of yourselves throughout this busy season and remember we are public servants to our community, providing an essential service to our rural family. Happy Holidays!

Working Together

During the recent District meetings, as I was listening to the Stewards' presentations on RRECS and RREDP (rural route evaluated dispute process), I was reminded of a proposal that was offered in 1992. It, too, was concerned with the grievances that resulted from the route evaluation time study, otherwise

known as the mail count.

The proposed plan would consist of joint management/labor teams. The objective was to eliminate the need for grievances

before the fact, utilizing education, training, and cooperation. As no plan is perfect, the proposal anticipated that some grievances might still be filed. In preparation for this eventuality, a compendium of possible circumstances along with its proper response would be produced. This would ensure that all cases with similar circumstances would be treated in the same manner. It was believed that this would end the need to fight the same fire numerous times at different locations.

The RREDP attempts to reduce/replace the grievance process with a new process, one that closely mimics it.

As the '92 proposal was a QWL/EI (Quality of Work Life/Employee Involvement) proposal from a management/labor team in what was then the Columbus District, I wondered if there were other proposals from QWL/EI that may have been manifested into something similar in today's postal world.

I found several projects centered around educating the public, and particularly businesses, on the policies and services available through the USPS in an effort to get them to utilize these services. In '92, the big push was to encourage businesses in the use of priority and express mail. Does this remind you of today's LEADS program?

Some projects dealt with communicating with the customer that they had a package delivered that day and where it might have been left due to prevailing weather conditions. Today, we have informed delivery and tracking, which almost does the same thing.

Some safety-related projects were signage and lights on our delivery vehicles, such as the U.S. MAIL rooftop sign with flashers. Today, we have the LLVs, with the NGVs having even better safety accouterments. Other projects worked with emergency services to publicly encourage residents to have visible addresses with 4" reflective numbers on both sides of the mailbox. This evolved into what is commonly known as the "911 address" signs today.

Quoting from a newspaper clipping (publisher unknown), "The Rural Carrier Academy and training is part of a national program that has had considerable involvement from the Quality of Worklife (QWL) process." Today's new hires get more training and orienting than ever before.

Many work teams took on the task of enhancing the "Brand" United States Postal Service. Working with local and district management, special cancellations were created for particular events. Fairs and festivals were attended, and occasionally, the philatelic van from the Columbus District was utilized. To introduce the Postal Service to society's youth of the day, the

Wee Deliver and Safety Town programs were presented to grade-schoolers in some areas. And we all know the importance "Branding" is to the CEOs of today, including Postmaster General DeJoy!

Thinking back over all of this, I haven't even begun to touch on the broad scope and variety of projects and proposals that came from carriers and managers across this great land we service. Time and space would not allow it.

The point is that carriers and managers working together came up with new and novel ideas, many of which you can see the fruits of today, and sadly, many great ones that should be visible today but have dropped by the wayside. Those efforts back then were admirable, worthwhile, and profitable in many ways. These are examples of craft and management being "engaged" with each other toward a common goal.

If a manager wants to "engage" me, don't waste my time by saying "good morning" and "how was your weekend?" That's not engagement, that's talking. Engage me by recognizing that we're equals, just with different jobs to do, and by working with me toward positive outcomes!

Secretary-Treasurer Report

OHRLCA Brothers and Sisters,

Penny Koren Secretary-Treasurer As of November 1, 2023, the Membership Analysis prepared by the National Office has Ohio's total membership at 4228. We have increased 29 members from last year. Ohio has 813 non-members. If your office has received a new RCA or ARC, recruit them to become a member of the

NRLCA. Help keep our Association strong by recruiting a non-member today. The 1187 authorization for dues withholding form is available on the ohrlca.org website.

RECENT RETIREES

No need to call - You will receive a letter instructing you how to remain an NRLCA Member. You will have 90 days after retirement to sign up as a member. If you do not continue your membership, your membership will expire. If you elect to remain a member, \$7.83 union dues will be taken out of your annuity, check each month, or you may elect to pay annually by the cash method of \$94. You must retain your union membership to continue your benefits of insurance and programs sponsored by the NRLCA. Even if you do not elect the Rural Carrier Health Benefits insurance program now, you may elect the Rural Carrier Benefit Plan in the future or add dental or vision programs. Do not let your membership lapse! Sign and return the 1187-R, authorization for dues withholding form, to keep your benefits.

OHRLCA DISTRICTS

A big "Thank You" goes to all of the Districts' Secretaries for completing and filing the LM-4 via the Internet with the Department of Labor. As per the OHRLCA Constitution Article III, Section 5 B.2, upon completion of all District reports and elections of officers, the Association made deposits into each District's Share Account. The deposits were calculated on the formula of \$10.00 per each regular and relief carrier member as of June 30, 2023.

2024 OHRLCA STATE CONVENTION

The convention will be June 3-5, 2024, at the Berlin Encore Hotel & Suites, 4365 State Route 39, Millersburg, OH 44654. The room reservation code will be forthcoming.

Delegate to the State Convention

Would you like to be a delegate to the state convention? To become a delegate, you must have your name nominated to be a delegate to the OHRLCA State Convention. Nominee elections will be held at each spring District Meeting. If you cannot attend your District Meeting, you may send a dated, signed request, prior to your district spring meeting, to the District Secretary, requesting your name receive a nomination as an OHRLCA State Convention Delegate. The elected delegates will receive credentials

for registration for the state convention.

What are the Requirements to be a Delegate to the State and National Convention?

1. You must be a member in good standing.

NRLCA Constitution Article III, Section 1 - Members

Member in Good Standing. A "member in good standing" is a member who has made timely payment of dues and has not voluntarily withdrawn or been expelled or suspended by the Association.

2. You cannot do management work.

OHRLCA Constitution Article III, Section 3 - Restrictions.

Inasmuch as it is an unfair labor practice under the Labor Management Relations Act (LMRA) for any employer (including persons acting in that capacity) to dominate or interfere with the administration of any labor organization, it follows those employers, while they may be members, may not be candidates for office or serve as officers. Members are prohibited from participation in the Association while serving in managerial or supervisory positions, such as Officer-in-Charge (OIC), Acting Supervisor (204-B), or Postmaster Relief (PMR) or acting in any capacity normally performed by a manager. Members who accept managerial positions shall be deemed to have resigned from all elected and appointed positions within the Association and shall be prohibited from holding any elected or appointed union positions for a period of one year from the last day served in that capacity.

TSP CONTRIBUTIONS

The New Year 2024 is fast approaching, and it is time to reassess your retirement investments. Contributing to the TSP is an absolute must for FERS employees who wish to retire and maintain their same standard of living. Many postal employees contribute 5% to their TSP because this allows them to get the full matching amount. This isn't enough. The "old" rule of "saves 10% and you'll be able to retire comfortably" is only true if you plan on working for the full 30 years. If you didn't become a regular carrier until age 40, you probably aren't planning on working until you have 30 years of USPS service, you must boost your TSP contributions. In 2024, you can contribute up to \$23,000 to the TSP program. If you are 50 or older, you can contribute an additional catch-up amount of \$7500. Catch-up contributions are made on top of your regular employee contributions; however, they do not receive any matching. To be eligible to make these special contributions, you must be on track to meet the IRS elective deferral limit. They are separate from the elective deferral and annual addition limits.


Remembering Our Earliest Carriers

What a Fall!



Dear Representative

I am writing as a rural carrier and constituent of your district to voice my strong support for the Federal Retirement Fairness Act. I urge you to cosponsor H.R. 5995, a bipartisan bill introduced by Representatives Kilmer, Connolly, Bacon and Valadao. The Federal Retirement Fairness Act would "amend title 5, United States Code, to provide that civilian service in a temporary position after December 31, 1988, may be creditable service under the Federal Employees Retirement System.."

Many federal employees, including Rural Carriers, start their careers as temporary employees. The Postal Service has a classification of Rural Letter Carriers called Rural Carrier Associates (RCAs). RCAs are part-time carriers who do not receive retirement benefits until they acquire full time career status. Most rural carriers start out as an RCA and on average it takes about six years for them to become a Regular Carrier, but it is not uncommon for it to take 10-plus years to become a regular career employee. The current retention rate of RCAs is extremely low, with approximately 60% leaving the Postal Service. This results in the Postal Service spending millions of dollars for the training/hiring process. Retention of RCAs would benefit the Postal Service by reducing overtime payments to RCAs and Regular Carriers attributed to the lack of RCAs.

Under this act, federal employees that gave their time and effort for years before achieving permanent status would be able to make catch-up retirement contributions so they may retire on time. This is not a new idea. Before the Federal Government changed to a new employee retirement system in 1989, temporary employees could make catch-up payments.

Please support H.R. 5995 so that the Federal Government can return to a fair retirement benefits system for all employees. We need your support to end the penalization of temporary employees who bring so much value to organizations such as the Postal Service. cosponsoring this legislation, you will help ensure that the government can attract and retain quality talent as well as ensure that our valued employees are not still struggling to achieve normal retirements.

USE OF SICK LEAVE AND FMLA

What is FMLA? The Family Medical Leave Act was created in 1993 and is a federal law. Under that federal law, the employer is required to provide unpaid job protection leave to eligible employees.

Who is eligible for FMLA? Any employee who has worked 1,250 hours in the previous

12 months is eligible and has been employed for at least 12 months with the Postal Service.

How many weeks/hours am I allowed to use without fear of losing my job? You may use a total of 12 weeks over the course of the entire leave year. Is the time used for dependent care part of the 12 weeks, or is it separate? It is included in the 12 weeks. Will I be allowed to use more days than I am allowed? Yes, when taking a parent/child/spouse to the doctor. For instance, the round trip to the doctor only took 3 hours. I would notify management that it was 3 hours. The 3 hours would be charged towards the 12 weeks of dependent care instead of 8 hours. Remember, sick leave in the rural craft is charged in one-day increments (8 hours).

Are there any cases in which I would be allowed more than 12 weeks Yes, a spouse, child, parent, or next of kin would be allowed 26 weeks for a covered (active or discharged in the last five years) service member who has a serious injury or illness.

Who is a dependent? ELM section 512.2 allows for a son/daughter, spouse, or parent. Are my mother-in-law and father-in-law included as a dependent? No, they are not included.

FMLA is granted for what reasons? FMLA is granted for any condition that may involve hospital care, chronic conditions, multiple treatments, pregnancy, or on-the-job injury.

What type of leave am I allowed to use? You may use sick, annual, leave without pay, continuation of pay (on-the-job injury), or a combination.

Will my leave increase if I have FMLA? No, it will not increase your annual or sick leave. It only guarantees time off from work without fear of losing your job or benefits. I called off and said it was FMLA, but management told me that I needed a doctor's note.

Do I have to bring in a note? Yes, just like any other absence, management can require you to bring in a doctor's note, especially if it is in conjunction with a holiday, your scheduled day off, or vacation days.

When can I schedule a doctor's appointment? Doctor's appointments are to be scheduled after work hours or on your day off. However, not all appointments can be scheduled after work hours, and management can request that you bring in a doctor's note.

I am off on extended leave. Can management make me provide medical documentation every month? Yes, you must provide documentation every 30 days or within 15 days of being requested for documentation.

What is acceptable documentation? It should advise the employer of the nature of the serious health condition, such as the carrier was incapacitated for work. What if I am injured on the job? Under continuation of pay or OWCP, this will count towards the 12 weeks of FMLA.

How do I get approval for FMLA? The employee submits Department of Labor Form WH-380-E, FMLA Certification of Health Care Provider for Employee's Serious Health Condition to HRSSC. How do I submit it to HRSSC? The mailing address is P.O. Box 970400, Greensboro, NC 27497-0400. The phone number is (877) 477-3273.

How long do I have to submit the paperwork? You have 15 days after receiving the request or returning to work. How long does it take to be approved? You should know if it has been approved or not within a week or so.

What should I do if I am denied FMLA? If it is denied, then re-apply and provide additional information relevant to the case.

Do I have to get it approved every year? Yes, you may be required to provide new medical documentation in each subsequent leave year.

Am I allowed to have more than one FMLA case in a year? Yes, but the total maximum time off for all cases is still 12 weeks. I have been off work due to a serious injury.

Can management require me to have a fitness for duty exam before I return to work? You must provide documentation that you are able to perform your job without any limitations. Yes, management can require you to get a second opinion from the person that they designate and pay for it. I did not use all 12 weeks last year, but I may need them this year. Is that allowed? No, unlike annual/sick leave, the unused weeks do not carry over.

Is management allowed to issue me discipline if I use FMLA? No, if you have approved FMLA and you have not used your 12 weeks, then it cannot be used against you for discipline. When in doubt, always protect yourself, as you do not know what the future may hold for you. If you have an extended absence from work and the reason may be protected under FMLA, then request the paperwork, follow through by filling it out and submitting it to HRSSC. Simply providing a doctor's note does not protect you from discipline. FMLA will.

INJURED ON DUTY: Did you know that if you are injured on the job, then you may be covered under C.O.P. (continuation of pay) for 45 calendar days? This is done by checking the box on the CA-1 form. This benefit does apply to all leave replacements as well. Leave replacements would be paid what their work hours averaged over the previous 12 months or since the appointment if less than one year.

OWCP: Regular carriers that are under OWCP are placed in protected salary commonly known as "E code." E Code means that your salary remains frozen at the time of the on-the-job injury. What does that mean? For instance, if your route evaluation would increase in evaluation, then you will not receive the salary increase. However, if the route decreases in evaluation, then you will not be taking a pay cut at that time. Where the problem lies is when you return to full duty, and management forgets to take you out of "E code." Eventually, EAGAN will catch the error, and you may receive a huge letter of demand.

How do I protect myself? Upon your return to full duty, request management to rescind the E code and document it.

Injured off Duty: It is heartbreaking when you receive these calls. A carrier is injured off duty and does not have enough leave to cover the necessary time off to heal. The carrier can request donated leave, but realistically, few district employees are going to donate their annual leave. The carrier can request advanced sick leave, but that is at the management's discretion.

What would you do if you found yourself in this situation, sitting at home with no paycheck? The best solution might be having short-term disability insurance, and it might be worth your time to check it out.

Off on Extended Leave: Article 12.3.B.5 clearly states that if you are going to be off on extended leave, then you should request in writing to your Postmaster/OIC that you wish to be notified of any bids for the rural craft. This written notification should include your name and mailing address as I would send it to my Postmaster by certified return receipt and keep a copy of the letter along with the return receipt for documentation if needed.

Mailing Address: Did you know, in accordance with the ELM section 665.5, that Employees must keep the installation head informed of their current mailing address? Any changes in mailing addresses must be reported to the installation head on PS Form 1216, Employee's Current mailing address, through "Self-Service" on the Postal Service Blue page (liteblue) or through approved methods, including PostalEase. You should notify the State Secretary/Treasurer, Penny Koren, so that you are receiving information in a timely manner.

Retiring and Letters of Demand: At the beginning of each leave year, regular carriers are advanced annual leave for the year with the understanding that the carrier will be working the entire year. If you are retiring before January 1, 2025, then you will need to pay attention to the portion on your paycheck stub that says earned annual leave. Do not use more leave that you have not earned, or it will generate a letter of demand in which you will have to repay those days back to the Postal Service. When you retire, you no longer have the benefit of the grievance procedure.


