No Representation Scheduled!

The NRLCA National Board has directed that there will be no steward representation at <u>any</u> state or local meeting from August 1, 2020 until further notice.

The OHRLCA State Board has decided to comply with the NRLCA directive and will not be sending State Board representatives to <u>any</u> meeting from August 1, 2020 until further notice.

Contact Your Congressional Representative Today!

H.R. 6425, the *Protect Our Post Offices Act*, will appropriate payment to the Postal Service Fund for revenue forgone due to the coronavirus pandemic, \$25,000,000,000, to remain available until September

30, 2022: Provided, That such amount is designated by the Congress as being for an emergency requirement pursuant to section 251(b)(2)(A) (i) of the Balanced Budget and Emergency Deficit Control Act of 1985 and shall be available only if the President subsequently so designates such amount and transmits such designation to the Congress.

"I hired a plumber to help



President's Annual Report

After our State Delegates elected me for this fourth year as your President, your State Board appointed constitutionally required positions at the post-convention meeting. We selected individuals who have shown outstanding skills related to those positions, and that we believe can do the best job

Vice-President's Annual Report

COVID-19 continues to change the way we live, do business, have meetings, doctor appointments, schooling, and more without saying. However, the USPS was already warning of financial trouble before this all started. The Postal Service predicts they will have enough money to complete 2020

but may run out before the end of 2021.

The Moving Forward Act was just passed by the House Democrats. It is a 1.5 trillion dollar infrastructure spending bill that will give the USPS 25 billion dollars to modernize postal buildings and operations.

Sounds great, right? But here comes the catch.

The bill states that 6 billion dollars must go toward buying a new vehicle fleet! However, 75% of the new vehicles must be electric or zero-emission vehicles by 2030.

Don't think we are out of the woods yet!

Republicans are fighting and trying to amend the bill to remove USPS funding. Some say the parcel increase is improving our numbers and reducing our losses. Some Republicans are leaning towards *The Cares Act* to allow the USPS to **borrow** 10 billion dollars from the US treasury department, however, both sides continue to discuss the terms of the **loan**.

President Trump has already stated that he thinks we should charge e-commerce enough to deliver the parcels. Not that there is more bad news, but that has to be moved through the Senate also.

That stated, we all need to call, write, or email both Senator Brown (D) and Senator Portman (R) and let them know they need to support legislation that helps the most trusted government agency - the USPS.

Let them know how we have been on the front lines during this pandemic. We kept our service to our communities and continue to do so 6 days a week, and a 7th to include Amazon parcel delivery! Medications were delivered to children, seniors, and veterans without delay! We keep Americans connected - especially in our rural communities. Your Ohio State Board members and the 2 Ohio PAC chairs had a conference call with Senator Sherrod Brown discussing the use of masks, hand sanitizer, second trips for parcels, and other general information for nearly an hour. We hope he takes the information we dispensed to the Senate floor to hopefully convince his peers that we need postal legislation.

The Board of Governors of the USPS is the board that sets the price of postage and oversees decisions the USPS makes. It includes the Postmaster General, Deputy Postmaster General, and appointed governors. We have a new Postmaster General, Louis DeJoy, who was a logistics executive. He replaces former Postmaster General Megan Brennan. President Trump supported DeJoy for this position. Postmaster General DeJoy's "Trajectory for Success" outlines the USPS's long term business plans and financial problems. It can be found online at link.usps.com.

As of June 2020, Deputy Postmaster General Ron Stroman stepped down. A new Deputy Postmaster General will be appointed and might very well be whoever DeJoy would like to work with. Also, David Williams, the former USPS Inspector General and Vice-President of the board resigned. Two other members also joined the board: Donald Lee Moak and Bill Zollars. Moak is a former pilot and President of the Air Line Pilots Association trade union (ALPA) and Zollars was the chair of a logistics company (YRC Worldwide).

Hopefully, we'll see President Trump putting the best people in place! We have the attention of the American people, the POTUS, the House, and the Senate. This is the time to send an email. I know we work for the USPS and "put a stamp on a letter" is our mantra (trust me - I get it) but, coming from the young men and women working in their D.C. offices, email is considered the preferred method of communication.

Secretary/Treasurer's Annual Report

I could have ever imagined that we would go through a global pandemic of this caliber. It is truly incredible to me. I hope that this horrible outbreak will soon end, and our association will continue business as usual.

Brothers and Sisters of the OHRLCA, it is a privilege to present my 2019-2020 annual report as Secretary-Treasurer of The Ohio Rural Letter Carriers' Association.

Membership

The 2019-2020 membership year began with 4,556 members and as of July 1, 2020, our total membership was 4,420, a decrease of 136 members. The decrease is contributed to several reasons, one reason is that relief carriers leaving our craft to become CCA, regular carriers becoming management, also the recently retired carriers are choosing not to remain as members.

In hope of recruiting newly hired rural carriers as members, your State Board continues to send recruiters to the new hire orientation. The recruiters have a 75% new member achievement rate, however, only 52% of the newly hired members remain as rural carriers after 90 days.

Below is a comparison of the membership for the years of 2013 – 2020.

Financial

The Financial report is for the Association year starting July 1, 2019, to June 30, 2020, is presented in this issue showing income greater than expenses by \$184,024.03. This increased income's largest contributing factors are the cancellations of the mid-state Conference, legislative conference, and the state convention.

Activity Report

July 13, 2019, I verified membership of all attending members at the Contract Ratification meeting,

August 11 - 16, 2019, I attended, as a delegate, the National Convention in Grapevine Texas. September 8th, I trained the District Secretaries, Treasurers, Presidents, and Vice Presidents on the procedures of conducting a district meeting and proper completion and filing of the LM-4 report.

I completed and filed the Labor Department required LM-2 for the State Association. The LM-2 report consists of many pages of detailed entries to account for every penny of income, where income was received from, expenditures paid to each

employee, the duties of each employee, and expenditures paid to each vendor of the Association. After completion, the report must be reviewed and signed by both the President and Secretary-Treasurer. The process of complying, completing, and filing took over 40 hours. The Labor Department requires all LM reports to be filed via the Internet. I assisted with the Districts LM-4 electronic fillings and I electronically filed the Association's LM-2.

The National Office requires me to complete Bonding Worksheets for each District and one for the State Association. The Bonding Worksheet for the State Association also must be submitted every three months to the National Office.

November 10, 2019, I assisted in the Fall Booster. In November, I completed and filed, via the Internet, the IRS 990 for the State Association and 14 IRS 990-e, one for each of Ohio's Districts. These 990 forms are the equivalent of a business IRS tax return. If the 990 are not filed with the IRS the Association / District would lose their non-profit status. The 990 for the association consists of 12 pages of detailed entries of income and expenditures, which took a mere 16 hours to complete.

This past year, I worked an average of 57 hours weekly to properly perform the Secretary/Treasurer duties as charged in the OHRLCA Constitution and to perform the additional duties assigned by the National Office. During the Covid-19 pandemic, some of our State events were canceled. Despite this fact, my work hours remained constant.

This past year, I attended all the board meetings, wrote minutes, wrote state paper articles, presented financial reports, paid all of the association's liabilities, balanced the checking and savings accounts 12 times, reconciled and paid the credit card 12 times, wrote 175 payroll checks, sent 512 retirement letters, completed 1 LM-2 Report, completed 15 IRS 990s, 53 IRS 940 tax filings, 4 IRS 941 guarterly reports, 12 SD-101 tax filings, 12 IT-501 tax filings, 4 BWC Payroll reports, 4 FUTA Tax reports, 4 JFS UC tax reports, wrote and filed and sent 26 W-2s and 5 1099 with the IRS and Ohio Taxation, completed and filed 18 bonding worksheets, wrote and sent 2408 membership recruitment letters, entered 524 - 1187/1187-R into the National database, processed and submitted 56 membership remittance reports, processed and submitted 56 membership summary reports, designed and printed 9166 meeting postcards, answered 906 phone calls as early as 5:30am and as late as 11:22pm, sent 58 cash due request letters, processed 49 cash dues membership cards, wrote 112 receipts, made 11 deposits, compiled 28 district member lists, compiled 28 district non-member lists, made 845 changes of address in the national database, wrote 368

letters to members on OWCP, processed 46 credentials to the National Convention, processed 197 credentials to the State Convention, and designed and printed 241 name badges for the State Convention.

I also provided numerous hours of assistance and consultation to the President, and members on the State Board, the District Officers, and members.

I have also spent many phone hours speaking with Senators and Congressional Representatives to protect six-day delivery, purchase all relief time toward retirement, and to end the prepayment of healthcare for 75 years in the future.

Along with the training courses, seminars, and conferences I was a guest speaker at Fall District Meetings, designed and printed district meeting postcards, sent membership recruitment letters, and assisted with the OHRLCA Website.

As a Secretary-Treasurer, I am also a board member. I make decisions in the best interest of the Association and its members, consistently following the OHRLCA Constitution and the Department of Labor's Laws. Making decisions is not an easy task, but it is a task that I take seriously. My decisions are lawfully driven and are not clouded by politics or driven by opinions or my own agenda.

position. I would like to thank the board for always being there for advice and guidance. I would love to thank the members for their ongoing kindness and acceptance. I appreciate the confidence you have shown me in this position.

It truly is a team effort to do all the many tasks that it takes to be part of the State Board. The Board conducted State and District Officers Training and state-based enrichment training. I am assigned to the Budget and a National General representative, along with writing articles for the Ohio Rural Letter Carrier.

I was scheduled to attend fall and spring district meetings, the Mid-States Conference, and elected as your delegate to the National Convention in Texas.

I am assigned to the Dayton PEDC for new hire orientations,

though I occasionally attend similar orientations in Cincinnati. I meet with newly hired RCAs for the union presentation for their new career. I explain the importance of joining the association. I emphasize the benefits of union-focused education and representation. Dayton usually has small groups and conducts orientations every two weeks. DID YOU Know?

NRLCA Stewards or Representatives who are removed from office for any reason (or no reason) currently have no appeal rights to challenge the decision? Did you know there currently is no federal law that provides whistleblower protection for union employees reporting corruption or misconduct within their unions?

The Labor-Management Reporting and Disclosure Act outlaws union corruption. However, the Supreme Court has ruled that the act's protections apply only to rank-and-file members—not employees—of labor unions. Internal whistleblower policies exists in *some* unions, however, if corruption exists, enforcement of those policies risk being stonewalled, ignored, or influenced by political ties.

Congressman Francis Rooney on H.R. 6922, the *Union Integrity Act*, introduced September 26, 2018: "Currently, union employees who uncover and report misconduct are vulnerable to retaliation by unions. This must be changed to protect these brave whistle-blowers from corrupt union bosses who threaten them or unfairly fire them. Corruption in unions is rampant; for example, high-ranking officers at the United Auto Workers (UAW) have been caught taking bribes. Without whistleblower protections, rank-and-file union employees are afraid to report these actions for fears of losing their jobs. The Union Integrity Act will right this wrong and protect union whistleblowers from being fired for reporting illegal behaviors, the same protections government and private business employees enjoy. This will encourage workers to report corruption and stop union abuse of employees."

Should PAC be silent on *Union Integrity*? Should our union press for safegards against internal corruption?

What is a PAC?

A Political Action Committee (PAC) is organized to raise and distribute voluntary donations to help elect/defeat candidates and lobbying for bills or legislation that impact the business, organization, or union of which it was formed to support.

History



PACs were created in the 1940s as an outgrowth of the American labor movement as a way to allow labor unions to contribute money to politicians sympathetic to the interests of their members. It is illegal for labor unions to contribute money directly to a candidate. However, they may sponsor a PAC and provide financial support for its administration and fundraising.

Oversight

PACs must file regular reports detailing who contributed money to them and how they, in turn, spend the money. (This is why receipts have to be completed when purchases are made with PAC)

Why is PAC so important for you?

When you support your NRLCA PAC by buying raffle tickets, merchandise, or monetary donations, you are supporting your future benefits, retirement, and all interests of rural carriers nationwide! You may not feel like you have a voice on Capitol Hill or even in your own post office. But, rest assured in

knowing that your PAC surely does have a far-reaching voice that is working hard with your support to protect the rural carriers, their families, and their future!

Hot Toples in the Stewardship

Coronavirus! COVID-19! Masks! If I never hear those words, I will be forever grateful. Our personal lives, as well as our work lives, have changed so much do to the unknown properties of this pandemic.

I want to **THANK YOU** for reporting to work every day and doing the best job that you can do! The wearing of masks being mandated months after the virus first appeared is sort of like closing the hen house door after the fox ate all the chickens.

Nevertheless, the Postal Service is our Employer and we are their employees. As a condition of our employment, we are required to wear seat belts. As a condition of our employment, we are required to wear leather shoes. As a condition of our employment, we are to follow the instructions of our managers.

Our Employer has mandated that we will follow the guidelines of our respective state governors. Ohio has mandated that employees will wear masks. The *only* way not to be required to wear a mask is if you have a medical condition and it is approved by the district nurse. Yes, you *may* be required to provide medical documentation. The Ohio Valley District is looking at those that cannot wear masks to providing them with face shields to wear.]

Every day, I am on telecoms over positive cases. Employees of <u>all</u> crafts are coming down with the virus. We are all frustrated with not having our lives back to normal. We long for the days of going places or on vacations, hanging out with friends and family. Despite all this, winding up on a ventilator is <u>never</u> a good option. It not only affects your lungs, but it affects your liver, kidneys, and brain as well. It is not an easy feat to come off a ventilator and have your life return to normal. Many people need to follow up with therapy just to be able to walk, etc.

People have lost limbs from this virus. Please do not become a statistic. Wear the masks, wash your hands, maintain social distancing to protect yourself as well as your loved ones.

Mail Volumes/Parcels: Another change in our work lives is the decrease in letters and flats. The latest figures show that DPS letter mail has dropped by 21.9% and all cased mail by 19.3%. I do not need to tell you that as you can see it every day on your route. Nor do I need to tell you about the increase of parcels. At one point we were up by more than 60% although lately, it has come down to an increase of 33.8%.

Online orders are increasing and *someone* must deliver it. Your National Officers have heard the complaints and have recently filed a step 4 over the increase in parcel volumes.

The Union is asking for any carrier that worked over their evaluations from PP 06 (February 29) forward to be paid overtime. City carriers were paid over 19 million over time. We have figured that the rural carriers across the country would be paid over 5 million in salaries.

2080-2240 Work Hours: The NRLCA current position is due to the insurmountable increase in parcels that we are not going to tolerate any actions taken by management such as the cutting of routes as an example due to 2080 issues. Nowhere does it say that we cannot work over 2,080 hours in the guarantee year. Carriers should never be forced to take leave without pay. If you are having problems with these issues, then contact your steward. If you do not know who your steward is, contact me.

FSS: In the next few weeks, the Postal Service will be taking over 700+ zip codes off the flat sequencing machines. It has even been reported that these machines will be dismantled. If your route is currently receiving FFS and is one of the zip codes on this list, then your route will receive a base hour change and all FFS flats will convert to raw flat count.

Route Inspections: Every year management is required to complete a route inspection, but this was put on hold due to the pandemic. On June 26, 2020, management received notification that they are to resume the annual route inspections. The inspector must maintain the six-foot distancing from the carrier and the wearing of a mask will be mandatory by both parties when the six-foot distancing cannot be maintained. The inspector must use a separate vehicle as they are prohibited from being in the same vehicle as you. If these guidelines are not being followed, then contact me immediately.

Reporting Times: Northern Ohio is currently looking at having no carriers report to work earlier than 15 minutes before the

office DUTS time (scheduled time that all mail is supposed to be ready). Article 30.1.G states that scheduling is the responsibility of the Employer. Schedules shall be realistic, based upon the receipt of the mail, the route evaluation, and other related service considerations. If management changes your reporting times, then you should have at least one weeks' advanced notice. As a reminder, we do not perform any work-related duties while not on the clock.

Second Trips: Past NRLCA President Dale Holton signed a Pre-Arbitration agreement on March 14, 2005, in which the parties agreed on what the compensation would be for a second trip. The compensation applies for those regulars and leave replacements being paid evaluated hours. It was agreed that the carrier would be compensated for two (2) minutes per mile, in addition to loading time.

Carriers that receive EMA would be compensated for each mile over 40 miles for the day that the carrier is required to drive.

The "second trip" is when a carrier makes additional deliveries after returning to the office due to mail being received <u>after</u> the carrier originally left for street duties. The intent was that we would not be retracing the entire route to effect delivery for late-arriving mail/trucks.

- Take note of time, date, and duration that you are loading and/or making additional trips.
- Ask to be compensated for actual time if you are making your third (or more) trips to deliver parcels.
- Ask to be compensated for actual time if you must retrace all or most of the route upon completion of the route.
- Ask to be compensated for actual time if mail was in the office but was not worked, and you are required to make a second trip.

The reference document to this topic is on the NRLCA website. Click "department", then "steward operations", then "Steward Reference Guide". Look for "second trips", and click on the document labeled "V-1".

Remember, knowledge is power.

Excessive Backing/Reverse: These issues have been addressed in both districts. Unfortunately, one district is being a little less reasonable than the other. Management has a right to have a job discussion with you, but they should be looking at the location of the alleged incident. The reports are not accurate, despite the Postal Service's claims.

Your stewards have repetitively proven when carriers did

not back up. For example, Management could try charging a carrier with reversing in a circular drive. Why would the carrier reverse 200 feet if they're inside a circular drive though? They could get to the same destination if they drove forward. This is how a 'circle' has always worked! It is ridiculous!

Scanner Alerts: The Postal Service sent out a standup talk targeting management. The alerts are not intended to be utilized, nor should they be cited, for corrective action with employees. Your Union will not tolerate any corrective action whether it be a letter of warning, suspension, or removal over this issue. Your Union will not tolerate threatening behavior from management on this issue.

Mercedes Metris: The Postal Service has notified the NRLCA that they will be deploying over the next three years 17,310 vehicles across the country. Northern Ohio rural carriers will be receiving 53 vehicles while Ohio Valley is scheduled for 148 vehicles. The assignment of these vehicles is your management's decision. Carriers will not be able to refuse them unless they have a 3-year waiver for their recent purchase of an RHD vehicle in place. Looking at the proposed lists, it appears that there is no reason but most of these vehicles will be going to auxiliary routes or in offices that already have some LLVs assigned to them. In some cases, the Postal Service will be putting these vehicles on high mileage route as well.

Filing a Grievance: The NRLCA has a new tracking system for grievances that are filed and either settled or appealed to the next step in the grievance/arbitration procedure by the local steward. Any time that you file a grievance with your local steward then you should be asked to sign-in on the blue grievance logbook which acknowledges that you have filed a grievance. If you are not being asked to sign, then contact me immediately. The local steward will be required to send the District Representative the pink copy. Regardless of whether the grievance has been resolved at step 1 or appealed to Step 2, the file will be sent to the District Representative. Local stewards will be held accountable for any grievance filed in their office.

Local Steward Elections: NRLCA Constitution Article IX, section 7.B.1 states, in part, "where a local steward is in place, any member may call for an election in the month of July of every fourth year. An election may also be called for any time that the position is vacant or when two-thirds of the members submit a petition to the District Representative for approval."

Members must be notified by placing a notice of an election. This is usually on the rural carrier bulletin board. This notice

must be hanging for a minimum of 15 days with the date and time of the election along with the names of the carriers who are running for the position. **Only NRLCA Union members may vote.** Upon completion of the election, the paperwork is filled out along with the ballots are sent to the District Representative. **The elected steward will have no authority until he/she has completed and successfully passed the training course.**

Training consists of a two-day training compensated by the NRLCA which has currently been modified due to the pandemic. The first day will be a self-study course day in which the elected steward will spend a paid day at home reading the material. The second day the elected steward will meet in person at a location. This day will consist of a review of the course material, taking the certification test, practicing some simple grievances, going over the NRLCA policies, etc. CDC guidelines will be followed. Some of the duties for the local stewards include:

- *Support and assist all rural craft employees in the office
- *Encourage membership in the NRLCA
- *Have labor/management meetings
- *Attend district and state meetings to become well informed
- *Respond to inquiries from the craft as well as management
- *Maintain the rural craft bulletin board
- *Handle of grievances with due diligence
- *Attend the yearly mandatory training
- *Uphold the National Agreement.

While in the performance of steward duties, regular carriers that have accumulated 8 hours will then receive a paid day off. Leave replacements performing steward duties are paid on a utility (green) card.

The further you go in the steward system; the more time is involved. As a District Representative or Assistant District Representative, it becomes very hard to find a balance between work life and personal life, not to mention the stress of the job. Recently two area stewards stepped down for various reasons. Long time Northern Ohio Area Steward Tana Humphrey, is stepping down as she is close to retirement, and Ohio Valley Area Steward Terri Clemens is stepping down due to health concerns. Both stewards will be greatly missed, and I thank them for their years of service and dedication to the betterment of the rural craft. I wish them much happiness and great health in their future endeavors.
